19th September is the launch date of a new currency in Bristol. The local pound is designed to be traded with registered local businesses [not multinationals] in an attempt to keep money local. The local Council is offering staff part payment in the **Bristol Pound** and businesses can pay local taxes in the currency. Designs on the notes include

local features such as Concorde, St Paul's Carnival Caribbean street festival and religious writer Hannah Moore. There will be four denominations including a £1 note. It is claimed that up to 80% of local income gets taken out of the area by big business. Bristol is not the first area in the UK to have its own currency, but it is the largest.

The farce concerning green power in this country continues to go where fiction would be ridiculed. Lord Deben, formally John Selwyn Gummer, who was Environment Secretary under John Major and Agriculture Minister in Margaret Thatcher's Government, is the newly designated chairman of the powerful **Committee on Climate Change** (CCC). It was set up to provide PM Cameron with apparently independent advice on energy policy and climate change. However this appointee is also chairman of Forewind, a consortium trying to build thousands of turbines in the North Sea's Dogger Bank. He is due to take over from Tim Yeo who holds paid directorships with AFC Energy[£55.450], which makes fuel cells, the biofuels company TMO Renewables[£68K], Eco City vehicles [£16K] and ITI Energy, which converts waste into biofuel. So no conflict of interest with either chairman then. Such bias illustrates the complete disregard and contempt shown for neutrality and balance in anything our government, or the EU for that matter, touches that affect the lives of the British people.

In a case of one in the eye for the German government, it is interesting to note that rich Greek shipping magnets are investing strongly in the cut priced **container ships** that are currently lying idle in Europe as a result of falling exports. Most of these ships were predominantly owned by failing German companies, something which provides a certain poetic justice as their country tries to destroy Greek business and asset strip the country. Already 39 airports, hundreds of ports, railways, motorways, sewage works, a couple of energy companies, banks, defence groups, casinos and even the country's national lottery have been put up for sale at Germany's Angela Merkel's insistence as part of the 'bail out' deals. Even some of the Greek islands, of which there are over 6,000, are at similar threat of being auctioned off, either individually or in part-island lots. Suggestions for funding the debt also include sales of Greek art and heritage. Asset stripping is never a popular solution, but the scale involved in Greece is nothing short of devastating. Greece must leave the Euro soon if it is to avoid annihilation.

We are looking forward with wild excitement to **Single Market Week** which starts this year on the 15th October. Celebrating 20 years of this abomination the EU will be spending loads more of your money in London [2 events],

Cardiff, Belfast and Edinburgh [1 each] plus more in the other 26 ensnared countries of the EU. There is even a special website giving details of festivities. Nearly £20K a time will be spent to ensure partygoers have a great time – cheers!

As if businesses have not enough daft and expensive regulations and diktats to contend with [e.g. sickpay for employees becoming ill on holiday], **new proposals** drawn up on behalf of the EU by Spanish MEP Alejandro Cercas and voted through the EUP last month will make businesses making job cuts measure how happy their staff are before and after redundancy and help those worst affected into new jobs. Under the rules, employers will have to measure the "psychosocial health" of staff before and after laying off people. If there is a significant deterioration in workers' mental health and well-being, companies would be forced to offer retraining, coaching on interview technique and general help with finding a new job as a compromise for letting them go. They will also have to outline the impact of redundancies on the local community, including how they would regenerate the area if significant job cuts meant thousands of local people were suddenly out of work.

Many months ago we warned readers that the EU was behind the creation of the **Mediterranean Union**, a union of the countries surrounding the sea on all sides. Some of the countries have come aboard, slowly. However others have blocked it, preferring their independence. Therefore the leaders of these states have to go - Gaddafi, Mubarak, Saddam are already history due to interference from the EU countries – is Assad the next to go?

The Centre for Economics and Business Research report that GDP in the **Eurozone has stagnated** whilst in the outside world many countries have maintained growth. In particular India, Africa and the Pacific region, all members of the Commonwealth are forecasting growth of 7%/pa over the next 5 years – overtaking the EU. Whilst UK exports to the EU have recently fallen by 7.3% exports to the rest of the world have grown by 13.2%, causing our sales to the Commonwealth to overtake those to the EU for the first time. Another good argument that we can safely leave the EU!



This month Jeremy Nieboer writes on State Education.

The GCSE results announced last week are a bitter testament to the denial and deception of socialists and professional educationists who hold that only the State should provide education and that any form of private provision is "unfair". Yet the unfairness inflicted on the young of being denied an equal chance of an education to fit them for life is of such an order as to constitute wickedness.

The top 80% of independent schools had an average of over 63% of their students achieving A* or A equivalent grades. In state schools only 15% were awarded an A or A*, down from 16.8% in 2011. This is a catastrophe for the students and a crippling handicap for the future of our country in a world that is now entirely competitive.

It is very difficult to find the separate statistics for State comprehensive schools as they are included in State schools data which of course include very high performing grammar schools where those still survive. The truth is concealed & the voices of those who speak out are drowned in the cacophony of outraged teacher trades unions. But parents will know that their children have fallen far behind and that they will not have the equal opportunity that is their right.

What compounds this disgraceful blight on the nation's youth is the fact that those in poor areas fall behind further than in wealthier areas. Comprehensive education provided by the State not only fails but also penalises those at most disadvantage. So far from "fairness" State comprehensive education has produced an educational apartheid for the poor.

The cause of all this failure is the endemic delusion that the State must provide education. But the State is a grotesquely inefficient provider of services and goods. It is deeply biased by political and social theory and its monopoly enterprises are dominated by trade union activists. But only 7% of us are able to afford private education. All the rest have to take what the State provides and are expected to be grateful.

In every part of our national life from which the State has been removed (steel and coal production, telecoms, transport, manufacturing) the result has been a bursting out of enterprise and variety with costs being sensitive to consumers.

As those who have read my articles will know I hold to the principle that **the State should do what the State alone can do**. Its primary function must be the security of the nation, both in defence and by its laws, and its relations with other nations. Above all it must raise revenues to promote conditions of equal opportunity for all.

Parents should be able to require that what the State expends on education be applied, at their direction, in meeting fees of the schools they choose. Schools will not only flourish but new ones will be created where and for whom they are needed. That alone will give hope for those now snared in the net of the comprehensive State regime.

A Salisbury resident Rex Poulton has pointed out in letters to the press that the Cameron/Clegg planning of **House of Lords reform** is actually illegal. For the House of Commons to interfere with the House of Lords 'is a criminal act. Under Common Law, each House has full cognisance as to who sits in it and how it conducts its business. Neither

House may interfere in the business of the other.’ We look forward to their arrest along with that of Teflon Tony whose House of Lords Act 1999 is similarly ‘ultra vires’.

The EU’s European Chemical Agency intends to introduce a European [despite the EU only consisting of 27 of the 45 European nations] wide ban on **lead shot**. This would apply to both the hunting fraternity and the military. Alternatives are now being sought by the military although these are expected also to be fatal when used!

Another EU-originated ban comes into force on the 1st September – the sale of 40watt **incandescent light bulbs**. 100watt and 60 watts are already banned. Most supermarkets voluntarily no longer sell such bulbs. However they can still be bought in their existing format in independent hardware shops until 2015, as stock last. The good news is there is another way round this stupid law. Industrial standard bulbs are not covered by this legislation and they can be still legitimately purchased in the form of ‘rough service bulbs’. These may be marginally dearer but are tougher physically to withstand commercial use. These are available in local shops and also on line. No need to suffer the dimwit bulbs!

With our dopey government and media seemingly unable to understand anything of a scientific nature we thought it might be helpful to them if we spell out some **obvious facts**. Thanks to the Woodhouses for this clarification:

Unfortunately the media and our politicians cannot grasp the difference between Carbon Particulates, which are put out mainly by diesel engines, that everyone has been encouraged by tax advantage to use, that do indeed add to air pollution and are injurious to health, and carbon dioxide, the totally benign trace gas that is essential to all life.

They are equally confused by Nitrous Oxide, which is a very nasty pollutant, injurious to health, or for that matter any of the other pollutants that are mainly rained down by overflying aircraft and by buses and taxis stuck in traffic jams. Most of this pollution is confined to our large cities. But and this is the point it has nothing whatever to do with CO2.

One can only think that the scientists are being misunderstood by an overexcited press, which in turn misinforms our politicians, or they are being deliberately malicious.
