



May we start this edition by congratulating the Duke and Duchess of Cambridge, William and Kate, on the birth of their first child, a son named George Alexander Louis. His Royal Highness Prince George of Cambridge is third in line for the throne and hopefully will secure the Crown till the end of this century. It is the first time since 1901 that the monarchy now has three generations of heirs for the throne.

Councils are quite rightly tightening up their income sources. One method is to adjust the time an empty property attracts a nil rate of **Council Tax**. Traditionally 6 months have been given but councils now have discretion on this. Some areas have reduced this tax-less period to 3 months. However Dorset North has now retracted the rate-free period on empty properties to just 1 month. This is particularly hard on landlords – one month is insufficient for them to clean, redecorate and re-let a property. Such a large increase in their expenses may lead to recuperation via increased rent levels, something that will not help those hoping to find accommodation at affordable rates. Thus in reality these greedy councils are just fleecing the less well off.

On the subject of councils, the Ferndown Town Council [FTC] still has a **vacancy** for a councillor to represent the Central Ward of Ferndown. It still remains after the recent rejection of one applicant. So if you would like to offer your services please contact Ian Jones, the Town Clerk as soon as possible. He will advise the way forward. There are already at least 6 UKIP councillors on FTC out of 22, so you will be well supported if you succeed.

We are informed that the **EU fraud** has risen by £15million since 2011 to a staggering £270m. Despite much posturing Brussels has clearly failed to get to grips with the problem. The European Commission budget report said the rise was almost entirely the result of two cases, one involving Croatia, of cheating involving large sums from countries wishing to join the community.

Recently Ariel Castro, aged 53yrs, the American jailed for imprisoning 3 women for 10 years, received a **life sentence** + 1,000 years. Needless to say he is unlikely ever to leave prison alive. So what would have happened to him in the UK? Latest legislation from the EU which has now been thrust upon us insists that a criminal cannot receive a life sentence without the opportunity to leave prison. So this evil creature would probably be out in 10 or 15 years and be free to commit further outrages to human dignity. What a sorry excuse of a legal system we now have thanks to the morons running the EU. This new interpretation of the law came to us predictably direct from the European Court of Human Rights who upheld complaints from murderer Jeremy Bamber and two other British lifers that keeping them locked up without any hope of a review was “inhuman and degrading treatment”.

Your **Mot** is about to become very different due to yet more legislation emanating from the EU. New requirements came into British Law in 2012 and will be introduced over a period of five years. These include new laws on HID lights, warning lights and engine management. Mike Natrass MEP, UKIP transport spokesman said: “These new rules will drive perfectly serviceable cars off the road, and hundreds of thousands of motorists back to the cash-point machine. These EU rules are just making life harder for people to get on with their normal lives.”

If your car is 30 years or more old further regulations will apply. The shake-up of the Mot system would cripple the car repair industry and cost thousands of jobs. The European Commission wants to exempt cars more than 30 years old from Mot testing – but only if they have not had any change in technical characteristics of their main components ‘such as engine, brakes, steering or suspension’. The AA said that if the law were passed, a car fitted with anything from updated brakes to larger alloy wheels would not pass its Mot and therefore could not be driven on Britain’s roads. ‘We don’t want this and we’re very much against it,’ said Vanessa Guyll of the AA. ‘Most modifications don’t affect a car’s safety. This would affect everything from changing a car’s wheels to fitting a bodykit. ‘No one enjoys taking their car for an Mot but our system is pretty good. The plan is ridiculous.’ The Federation of British Historic Vehicle Clubs said more than 28,000 people are employed in the historic car industry and estimated that it contributes £4.3billion to the economy. It described the proposals as ‘unworkable and completely unacceptable’.



A new report by the House of Commons Energy and Climate Change Committee has warned that, based on Government estimates, **green levies** will add a third to electricity prices by 2020 – even before expected rises in wholesale prices are factored in.

Jeremy Nieboer: Wishful thinking, waste and squandering of taxed earning.



History instructs that when dispassionate regard of reality is displaced by belief, prejudice or the narcotic of wishful thinking we become vulnerable to events and superseded by those ready to accept the truth of their situation. So it was for Germany and Japan from 1945 – 1990 when we lost much of our traditional manufacturing to them.

This malaise also applies to apparently liberal beliefs that are considered in some way virtuous but which in reality are false and destructive. Among these are the doctrines of "appeasement" in the 1930s, "laissez faire" in the 1840s and trade mercantilism of the 16th and 17th centuries. Today the obsession with the notion of climate change shows how virtuous belief gives rise to the gravest crisis in our energy supplies that we have ever faced in peacetime bringing havoc on industry and hardship on the poor.

In politics the dominant virtuous belief is that only the State is to be trusted to provide the essentials of a fair society in health and education. This was the paramount assumption of the Socialist movement having its origins in Britain in the 1820s with industrialisation and the gross inequalities of health, education and opportunity that it brought into shocking focus. So it was that when the Socialist movement secured an unassailable majority in 1945 it determined not only that all should have equal access to health and education but that these benefits would be provided by the State.

The State is, as I have shown in earlier articles, unable to provide services or goods save at unacceptable cost, delay and inefficiency. After a period – which may be years – it becomes incapable of responding to the needs of the consumer since, not being dependent on consumer choice, it falls inexorably into a condition in which its enterprises are managed as much for the benefit of its managers, employees and consultants as for patients parents and children.

Whilst we cannot at a stroke expect that the State will cease to be the provider of health and education and transfer the funds it takes in taxes to patients and parents, we must surely insist that our political leaders openly acknowledge that these failing State enterprises must bear their share of the cost of financial and economic recovery. In 2009/10 public spending (adjusted to current prices) was £634bn. In 2011/12 it was 645bn and is now £647bn. It has not been cut. It is increasing.

Despite the supposed pay freeze public sector pay is 8.2% higher than in private sector and rising. Guaranteed pensions increase it even further. This is with job security unavailable in the private sector. Study after study show there is no correlation between more spending and better health or education. The Taxpayers Alliance has demonstrated that £120bn of gross waste can be saved without cutting NHS or education budgets. But we must now all accept that gross waste is endemic in these budgets and that savings must accordingly be made for the benefit of us all.

Recently **Ian Smith**, your UKIP County Councillor, has circulated a two page epistle relating to his experiences at County Hall. It is too lengthy to include here in full so we are reproducing two paragraphs to give you a flavour of his experiences as the lone voice of UKIP in the DCC.



"To enter County Hall for someone who has never been in local government, or had any interest in it, is daunting. It's a massively complex, vast, bureaucratic organisation made even worse when you start to add to it the district, town, parish and unitary councils and all of their structures and responsibilities. It is steeped in strange traditions and ways of doing things and a whole new vocabulary that I call local government gobble-de-gook.

In addition, there's massive information overload. Every day there are outpourings from all the numerous committees and sub-committees, invitations to attend all manner of updates and information events from different areas of the council, invitations to attend events from interest groups or partners, endless emails with multiple 100 page PDFs attached, invitations from the Local Government Association and invitations from UKIP HQ to attend meetings in London etc. Also all the emails from residents and pressure groups who want your help and support."

The UKIP Forum newsletter has told us that the closure of the **Ford Transit** factory in Southampton has been branded as "scandalous" by our leader Nigel Farage, with production moving from Swaythling to Turkey thanks to the European Investment Fund. This is purely the result of the European Investment Bank offering a €190 million

loan for Ford's relocation last December. The EIB is the bank of the European Union. "Over 500 British workers are set to lose their jobs thanks to this closure, it is outrageous," said Farage. "Yet again the EU is putting British people out of work and transferring jobs to foreigners. We must be crazy and the fact that the government is allowing this is a scandal. Only UKIP stands up for British workers. We don't believe they are lazy and useless - we believe that they deserve a government that backs and believes in them."

Cameron and Co. have come up with a brilliant way of kick starting **building** and the ownership of homes in the UK. What a super idea! Many would-be homeowners might qualify for a deposit of up to 20% paid for by you and me – though no doubt funded by more government borrowing. Just one little problem with this – It is not only Brits who would be able to receive this step up the housing chain – in the name of equality we would have to allow immigrants from the EU to have these handouts, few if any of whom have contributed much to our economy.
